**Residential Service**  
**(General)**

**Availability**

This Schedule is available when electric service is used for domestic purposes in and about residential dwelling units, including electric service used on a farm and in the preparation of the farm's products for market. A residential house served under this Schedule may be used as a boarding house, fraternity house, tourist home, or like establishment, provided such residential house is one which ordinarily would be used as a private residence.

Service under this Schedule is not available for processing (or handling) for market of farm, or agriculture products, for separately metered farm operation for individual motors in excess of 10 HP (in exceptional cases, motors as large as 15 HP may be served upon approval by the City), for commercial or industrial purposes, or for other uses not specifically provided for by the provisions herein, or for breakdown, supplementary, or resale service.

Non fossil energy sources caused by acts of nature such as wind or solar are permitted as supplement to Customer's energy requirement provided the City is granted the right to install, operate and monitor special equipment to measure Customer's load or any part thereof and to obtain any other data necessary to determine the operating characteristics and effects of the installation.

Generation may not be interconnected to the utility system or operated by the Customer with service provided under this Schedule without prior written approval from the City. The Customer must install equipment acceptable to the City to protect personnel performing maintenance or repairs and prevent damage to electric system facilities. The Customer is responsible for any injury or damage caused by the operation of such generation. The Customer's electric service is subject to immediate suspension without notice until adequate protection equipment is installed and approval for generation operation is obtained from the City.

**Applicability**

This Schedule is applicable to all electric services of the same available type supplied to the Customer's premises at one point of delivery through one kilowatthour meter.

**Type of Service**

The types of service to which this Schedule is applicable are alternating current, 60 hertz, either single-phase 2 or 3 wires, or three-phase 4 wires, at the City's standard voltages of 240 volts or less.

**Monthly Rate**

Single-Phase Service

Summer (Billing months July-October)  
\$12.76 Basic Customer Charge  
12.414 cents per kWh for all kWh

Winter (Billing months November-June)  
\$12.76 Basic Customer Charge  
10.998 cents per kWh for all kWh

**Three-Phase Service**

The monthly bill computed for single-phase service plus \$11.31.

**Energy Conservation Discount Code E27**

Where Customer notifies City and Customer's dwelling complies with the Thermal Requirements herein, the above-stated kWh charges will be discounted by 5% per kWh.

Summer (Billing months July-October)  
\$12.76 Basic Customer Charge  
11.793 cents per kWh for all kWh

Winter (Billing months November through June)  
\$12.76 Basic Customer Charge  
10.448 cents per kWh for all kWh

**Payments**

Bills are due when rendered and are payable within 20 days from the date of the bill. If any bill is not so paid, the City has the right to suspend service in accordance with its Service Regulations. In addition, any bill not paid on or before the expiration of 20 days from the date of the bill is subject to an additional charge of 1.5% with a minimum of \$5.00 to the balance in arrears.

**Sales Tax**

To the above charges will be added any applicable North Carolina Sales Tax.

**Effective Date**

Effective for billing rendered on or after February 1, 2006.
